

'Zara Promotion November promotion 2013' Terms & Conditions ("Conditions")

1. The Zara Promotion November Promotion (the "Promotion") is organized by Marina Bay Sands Pte. Ltd. ("MBS"). The Promotion is from 10:00hrs on 4th November 2013 and ending on 30th November 2013 at 22:00hrs (the "Promotion Period").
2. During the Promotion Period, a minimum spend of S\$200.00 from 3 combined same day receipts at Zara at The Shoppes at Marina Bay Sands (the "**Mall**") entitles a shopper to redeem 1 x \$30 Marina Bay Sands Shopping Voucher (the "Promotion Voucher") (the "Redemption"). The Redemption shall be subject to the following: (i) one Redemption per \$200 spend ; and (ii) limited to 600 redemptions during the Promotional Period on a first come first serve basis.
3. To be entitled to this promotion spend must be made only at Zara at the Mall. Zara receipt must be presented as proof of purchase up to the total spends.
4. Receipts for bill payments, installment plans and voucher purchases are not eligible for the Redemption.
5. The Promotion Voucher can only be redeemed on the date of the relevant receipt(s). Shoppers must present their NRIC/passport and original receipt(s) at the Redemption Desk – Concierge Desk located at the Canal Level, B2 (outside of Zara) for the Redemption.
6. The Promotion Voucher is only valid for use at participating stores in the Mall that accept Marina Bay Sands shopping vouchers.
7. The Promotion Voucher is non-transferrable, non-exchangeable and non-cashable.
8. At any time and without prior notice, MBS may revise, amend or delete any part of these Conditions or terminate the Promotion at its absolute discretion and all participants shall be bound by such amendments or termination.
9. The Promotion is not open to (i) the employees of MBS and its tenants in the Mall and (ii) shoppers who are below 18 years old. MBS reserves the right to not issue the Promotion Voucher to any shopper that is determined by MBS, at its sole discretion, to be non-eligible for the Promotion.
10. MBS' interpretation of these Conditions and MBS' decision on all matters relating to the Promotion, including in the event of dispute, is final, conclusive and binding. MBS shall not be obliged to give any reason or enter into any correspondence with any party on any matter relating to the Promotion.
11. The Promotion is not open to (i) the employees of MBS and its tenants (including the employees or contractors of the tenants) in the Mall; and (ii) shoppers who are below 18 years old. MBS reserves the right to not issue the Promotion Voucher to any shopper that is determined by MBS, at its sole discretion, to be non-eligible for the Promotion.
12. A person who is not party to any agreement governed by these Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement or these Conditions.
13. These Conditions shall be governed under Singapore Law and the participants shall be deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.
14. By participating in the Promotion or accepting the Promotion Voucher, the participant agrees that no claim relating to such losses or injuries (including special, indirect and consequential losses) shall be asserted against MBS, its parent companies, affiliates, directors, officers, employees or agents from any and all losses, damages, rights, claims and actions of any kind resulting from the Promotion and acceptance of any gift, including without limitation, personal injuries, death and property damage.
